### **New Business**

The board recommends a new board position for our liaison between WALC with USLCA and IBLCE. Kathie moved that this be an appointed position. Donna seconded. All agreed. Lisa Brock is currently filling this position and will fill the board position.

**New Medications and Mother’s Milk book out** – There will not be another giveaway, but members will be offered the books at a discounted rate this year. Members will be able to purchase up to two books at \$20 each and up to five more for \$25 each. (The retail cost to buy a single book is \$36 plus shipping.)

The books will be available for purchase at the September and November meetings. If you want books to be shipped to you, you will need to pay shipping. Any leftovers will be sold at the WALC conference. See the website for more information.

Dr. Hale will be starting up a national call center, where mothers and their doctors can get answers to their questions about medications during pregnancy or lactation. The board decided that contributing to the call center and publicizing it around the state would be a better use of our funds than buying books for a few locations.
