Angela has developed a provisionary policy brief for IBCLC licensure here in Wisconsin. Recommended that after our meeting in September, for those who want to stay afterwards we can discuss this issue as it will take many. Possibly breaking down the tasks to regions? Who could we get to sponsor a bill?
