- VIII. USLCA Report by Angela Lang.

- b. WALC representatives Angela Lang, Jennifer Statz and Kim Welvaert attended the ILCA conference in Washington DC in July. Angela noted that there were 1,000 attendees and at our WALC conference we have close to 400. New York is the only other state with as many attendees at their conferences. Angela and Kim attended a USLCA meeting where they shared all that we're doing here in Wisconsin.
- c. WALC uses money raised with our yearly conferences to fund things such as freezers for the Mother's Milk Bank of the Western Great Lakes http://milkbankwgl.org/, Tongue Tie Project, supported Josefine in Uganda and more. Angela then went into detail about how our goal was to help Josefine become an IBCLC. However, in the area that Josefine is working, having the IBCLC credential wouldn't help her. WALC Board decided to reach more within our own state this year by sending 4 minority women (3 African American and 1 Native Indian) to the CLC course.
- d. USLCA and ILCA partnership has changed. Now able to be a member of USCLA, ILCA or both.
- e. The USLCA web site has information on how to explain to the public about differences between CLCs and IBCLCs. https://uslca.org/resources/publications. Encouraged focus on how everyone is helpful to our breastfeeding families. WALC has a mentoring program to connect a CLC with an IBCLC.
